When a **“PIC FREEZE”** has been processed for you, you must have this **“PIC FREEZE”** removed by KTCI when you decide to change long distance carriers. Please notify KTCI & your long distance carrier whenever you are canceling &/or changing from one long distance carrier to another. Failure to do so may result in higher rates, since, in all likelihood, you will not be placed on the particular calling plan that you desire. Lifeline Telephone Assistance Programs

are available for qualifying subscribers. These programs provide a monthly service discount on telephone and broadband services. Toll blocking at no charge and reduced deposits are also available with the **Lifeline Program**. To Qualify for **Lifeline**, subscribers must either have a household income that is at or below 135% of the Federal Poverty Guidelines, or the subscriber, one or more of the subscriber's dependents, or the subscriber's household must receive benefits from one of the following assistance programs:

- ***Medicaid**
- ***Federal Public Housing Assistance**
(Section 8)
- ***Supplemental Nutrition Assistance Program (SNAP)**
- ***Supplemental Security Income (SSI)**
- ***Veteran's Pension and Survivor Benefit**

A subscriber living on **Tribal lands** and is eligible for **Tribal Linkup** and **Tribal Lifeline**. They may also qualify for **Lifeline** by participation in any of the above-listed qualifying assistance programs or one of the following Tribal-specific federal assistance programs:

- ***BIA General Assistance**
- ***Tribally Administered Temporary Assistance for Needy Families**
- ***Head Start** (if income eligibility criteria are met
- ***Food Distribution Program on Indian Reservations (FDPIR)**

Tribal subscribers may also qualify if the household income is at or below 135% of the Federal Poverty Guidelines.

KTCI's voice and bundled broadband services are **Lifeline**-supported services.

Only eligible consumers may enroll in the **Lifeline Program**. **Lifeline** applicants must present documentation demonstrating eligibility either through participation in one of the qualifying federal assistance programs or through income-based means. **Lifeline** recipients are required to recertify their eligibility every year.

The **Lifeline** program is limited to one benefit per household. A household is defined for the purposes of the **Lifeline** program, as an individual or group of individuals who live together at the same address and share income and expenses. **Lifeline** is a government benefit program, and consumers who willfully, make false statements in order to obtain the benefit can be punished by fine, imprisonment or can be barred from the program.
